The information set forth below is based upon 15,393,309 shares of Common Stock outstanding as of November 1, 2018, as reported in the Form 10-Q of the Issuer filed with the SEC on November 6, 2018. Such percentage figures are calculated in accordance with Rule 13d-3 under the Securities Exchange Act of 1934, as amended.

The Convertible Preferred are only convertible to the extent that after giving effect to such conversion the holders thereof and their affiliates would beneficially own, for purposes of Rule 13d-3 under the Securities Exchange Act of 1934, as amended (the "Exchange Act"), no more than 4.99% of the outstanding shares of Common Stock of the Issuer after conversion ("Beneficial Ownership Limitation"). As a result of this restriction, the number of shares that may be issued upon conversion of the Convertible Preferred by the above holders may change depending upon changes in the outstanding shares of Common Stock. The number of shares issuable upon conversion of the Convertible Preferred held by any Reporting Person affiliate will also depend upon the extent to which the Convertible Preferred, as the case may be, held by other affiliates have theretofore been converted as applicable. For the Convertible Preferred by written notice to the Issuer, the Funds may from time to time increase or decrease the Beneficial Ownership Limitation applicable to that Fund to any other percentage; provided that any such increase or decrease will not be effective until the 61st day after such notice is delivered to the Issuer.

Pursuant to the management agreements, as amended, among the Adviser, the Funds and their respective general partners, the Funds' respective general partners relinquished to the Adviser all discretion and authority with respect to the investment and voting power of the securities held by the Funds, and thus the Adviser has complete and unlimited discretion and authority with respect to the Funds' investments and voting power over investments.

The Adviser GP, Felix J. Baker and Julian C. Baker as managing members of the Adviser GP, and the Adviser may be deemed to be beneficial owners of securities of the Issuer directly held by the Funds, and may be deemed to have the power to vote or direct the vote of and the power to dispose or direct the disposition of such securities.

The Reporting Persons disclaim beneficial ownership of the securities held by each of the Funds, and this Schedule 13G shall not be deemed an admission that the Reporting Persons are the beneficial owners of such securities for purposes of Section 13(d) or for any other purpose.
